GENERAL INFORMATION

Dyna Gold Summer Turf Special is a liquid foliar formulation designed to correct and prevent the most common mineral deficiencies in many grass species. Dyna Gold Summer Turf Special contains amino acids which may enhance beneficial soil microbes. A jar-test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and/or urea will aid in plant uptake.

APPLICATION RECOMMENDATIONS

Turf/Sod/Lawns: Apply 2½ gallons of Dyna Gold Summer Turf Special per acre (7 oz. per 1000 sq. ft.) in enough water to cover.

Shrubs: Mix 1 gallon of Dyna Gold Summer Turf Special per 100 gallons of water and spray to run-off.

DIRECTIONS FOR USE

Dyna Gold Summer Turf Special should be applied at least once a month in enough water to allow for thorough coverage, usually a minimum of 2½ gallons per acre (7 oz. per 1000 sq.ft). **Fertigation:** 30 gallons of Dyna Gold Summer Turf Mix may be mixed in 1000 gallons of water and applied through any type of irrigation system.
