## VEGETABLE MIX LIQUID FOLIAR SPRAY

### PRODUCT INFORMATION

DynaGold Vegetable Mix is a liquid foliar formulation designed to correct and prevent deficiencies in vegetable crops. If added to the spray tank first, DynaGold Vegetable Mix will aid in lowering the water pH. A jar-test to check the compatibilities of new or unfamiliar chemical combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and /or urea nitrogen will aid in uptake.

### DIRECTIONS FOR USE

DynaGold Vegetable Mix should be applied at weekly intervals starting with the first spray at 1 to 2 quarts per application in enough water to cover. Aerial application: 1 quart per acre in 5 to 15 gallons of water.

### CROP RECOMMENDATIONS

**Vegetable Crops:** Beans, cabbage, cantaloupe, celery, cucumber, eggplant, endive, lettuce, greens, peas, melons, pepper, potatoes, squash, strawberries, sweet corn and tomatoes, use 1 to 2 quarts per acre in weekly applications up to first harvest.

**Turf:** Apply 2-4 oz. per 1000 sq. ft. in enough water to cover. Repeat at regular intervals. In Florida, application rates should not exceed the recommendations in "BMP's for the Enhancement of Environmental Quality on Florida Golf Courses" found at <http://www.dep.state.fl.us/water/nonpoint/pubs.htm>
