PRODUCT INFORMATION

Dyna Gold Calcium is a chelated secondary plant nutrient that will aid in supplementing the crop's calcium requirement throughout the growing season. When used as part of a balanced fertility program, it will correct and prevent calcium deficiencies, especially in rapidly expanding foliage and fruiting structures. It is not designed to correct soil pH or to provide the total calcium requirements of the plant.

CROP RECOMMENDATIONS

Fruits, Nuts and Vine Crops (including citrus, peaches, pecans, apples, pears, grapes, etc.): Apply 2-3 quarts per acre in enough water to allow for thorough coverage.

Foliage & Ornamentals (including ferns, hibiscus, caladiums, viburnum, ligustrum, roses, etc.): Apply 1-2 quarts per 100 gallons of water as a drench or as a foliar spray.

Vegetables (including solanaceous, brassica and cucurbit crops): Apply 1-2 quarts per acre in enough water to allow for thorough coverage. Repeat at regular intervals as necessary.

Field Crops (including cotton, corn, peanuts, sugar cane, peas and beans): Apply 1-2 quarts per acre in a minimum of 20 gallons of water per acre. Repeat as necessary.

Turf, Lawns, Sod (including Bermuda grass, Floratam, Zoysia and Carpetgrass): Apply 6-8 ounces per 1000 sq. ft. in enough water to allow for thorough coverage.

Repeat every 14-21 days as necessary. **Fairways:** Apply 3-5 gallons per acre in enough water to cover. In Florida, application rates should not exceed the recommendations in "BMP's for the Enhancement of Environmental Quality on Florida Golf Courses" found at: <http://www.dep.state.fl.us/water/nonpoint/pubs.htm>

DIRECTIONS FOR USE

1. Do not mix with foliar or ground applied liquid fertilizers containing phosphates.
2. A jar test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application.
3. Aerial Application: Use recommended rate in 5 to 10 gallons of water per acre.

PRECAUTIONS

Avoid getting in eyes, mucous membranes or on skin. Use of side-shielded safety glasses is recommended. Use with adequate ventilation. Keep container capped when not in use. Do not contaminate feed, seed or water supplies. **NOTE:** Avoid spraying on concrete or painted surfaces as staining may occur.

FIRST AID

Skin: Remove contaminated clothing. Wash with plenty of clean water and soap. Consult a physician.
Eyes: Rinse with clean water for a minimum of 15 minutes. Seek medical attention.
Internal: Drink 2 glasses of water. **DO NOT INDUCE VOMITING.** Seek medical attention at once.
