DynaGold Hi-Cal Cotton & Bean Mix (DynaGold Hi-Cal) is a liquid foliar formulation designed to correct and prevent deficiencies in cotton, beans, and many other crops. **DynaGold Hi-Cal** will also influence the activity of certain enzymes in cotton and legumes. A low supply of Calcium may result in larger plants with fewer fruiting forms. If added to the spray first, **DynaGold Hi-Cal** will aid in lowering the water pH. Check compatibilities of untried chemical mixes. The addition of a non-ionic surfactant, will aid in spreading and uptake.

DIRECTIONS FOR USE

DynaGold Hi-Cal applications may be initiated as first true leaves appear at 1-2 quarts per acre in enough water to cover. Repeat as needed throughout the growing season. **Aerial Applications:** 1-2 quarts per acre in enough water to cover.

CROP RECOMMENDATIONS

DynaGold Hi-Cal may be used to prevent deficiencies on the following crops: alfalfa, almonds, avocados, apples, barley, beans, broccoli, cabbage, cauliflower, carrots, celery, citrus, corn, cotton, cucumbers, eggplant, grapes, lettuce, milo, melons, nectarines, rice, pears, peaches, pecans, peppers, plums, potatoes, peanuts, strawberries, tomatoes, turf, turnips, watermelons and wheat.
