PRODUCT INFORMATION

Dyna Gold Manganese is a liquid foliar formulation designed to correct and prevent manganese deficiencies in crops. A jar test to check the compatibilities of new or unfamiliar combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant will aid surface coverage which will help leaf absorption.

CROP RECOMMENDATIONS

Citrus and Fruit Crops: Use 2 to 3 quarts per acre per application in enough water to allow for thorough coverage but not to run off.

Vegetables Crops: Beans, cabbage, cantaloupe, celery, cucumber, eggplant, endive, lettuce, greens, peas, melons, pepper, potatoes, squash, strawberries, sweet corn and tomatoes, use 1 to 2 quarts per acre in enough water to allow for thorough coverage but not run off. Repeat every 2 days as necessary up to first harvest.

DIRECTIONS FOR USE

Dyna Gold Manganese should be applied as needed starting with the first spray at 1 to 2 quarts per application in enough water to allow for thorough coverage but not run off. **Aerial Application:** 1 quart per acre in 5 to 15 gallons of water.
