

# DYNA GREEN™ TF

## TURF FORMULA

### General Information

Dyna Green TF is a liquid foliar formulation designed to correct and prevent the most common mineral deficiencies in many grass species. When used first in the mixing order, it will help in reducing the pH of the final spray solution. A jar-test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and/or urea will aid in plant uptake.

### Directions For Use

Dyna Green TF should be applied at least once a month in enough water to allow for thorough coverage, usually a minimum of 40 gallons per acre. When spray volumes lower than 40 gal/acre are used, water in after application. **Fertigation:** 30 gallons of Dyna Green TF may be mixed in 1000 gallons of water and applied through any type of irrigation system.

### Crop Recommendations

**Turf/Sod/Lawns:** Apply 3-6 oz. per 1000 sq. ft.

**Bahiagrass:** Apply 2-3 oz. per 1000 sq. ft. and repeat every 30 days.

**Bermudagrass:** (including Tifway and other hybrid varieties): Apply 4-6 oz. per 1000 sq. ft. and repeat every 15 days.

**Carpetgrass:** Apply 3-4 oz. per 1000 sq. ft. and repeat every 30-60 days.

**St. Augustine grass:** (including Floratam): Apply 4-6 oz. per 1000 sq. ft. and repeat every 7-15 days.

**Zoysiagrass:** (especially on calcareous soils): Apply 6-8 oz. per 1000 sq. ft. and repeat every 7-15 days.

**WARNING**

**Prevention:** Wear protective gloves and chemical splash-proof goggles. Do not breathe vapors, mists or sprays. Wash thoroughly after handling. Use only outdoors or in a well-ventilated area.
