## PRODUCT INFORMATION

pHury is a specially formulated blend of a major and a secondary nutrient required for plant growth. Both sulfur and nitrogen are required in the formation of amino acids such as methionine and cysteine that are essential building blocks in many enzyme reactions. pHury may be applied as a supplement to regular applications of fertilizer to reduce alkaline deposits in drip irrigation lines and to prevent sulfur deficiency.

## DIRECTIONS FOR USE

pHury is solely intended for soil application through drip irrigation lines or micro-sprinklers. It should be injected as a supplement to your regular fertilizer program and should not be used to adjust pH or correct alkaline soil conditions. pHury may be used to prevent emitter plugging and reduce bicarbonate content of irrigation water. **NOT FOR FOLIAR APPLICATION.**

## RECOMMENDATIONS

Crops grown on mulched plastic beds with drip tape systems (including strawberries, squash, peas, beans, tomatoes, and peppers): Inject 1-3 gallons per acre every 7 to 21 days and water in. Tree crops grown under drip or micro-sprinklers (including citrus, pecans and other deciduous and tropical crops): Inject 1-3 gallons per acre every 7-21 days and water in. **DO NOT USE ON STONE FRUIT.**
